

Residency Verification Application and Residency Affidavit for SVRSU #12

The following information and signed affidavit of residency are required before a student will be permitted to enroll in any school as a tuition student. The Town of Alna reserves the right to request additional information needed to evaluate tuition payment requests on a case-by-case basis. This form must be filled out and residency verified by the Town Clerk and signed by Two of Alna's Selectmen and the Superintendent of SVRSU #12 before registering a student at a school outside of SVRSU #12

Parent/Guardian Certification of Residency

Must show proof of residency. In the case of a property owner, must show current homestead exemption for Alna property. In the case of a renter, a current year-long rental/lease agreement showing parent's name & physical address in Alna. In the case of divorced parents, must show a certified divorce decree showing primary custody awarded to parent who resides in Alna.

All parents or guardians having any parental rights concerning school age children seeking school attendance privileges in Alna and SVRSU #12 must sign this affidavit.

I understand that making a written false statement may result in civil liability and may constitute crime under Maine law. I certify that the information contained herein is true and correct, that I am the parent or guardian with legal custody of the above-named student, that I actually live with the above named student in Alna at the above address, that we actually live there throughout the year, and that I am not claiming residency in any other place for any other student for the purpose of school admission or tuition for that school year. If any of the above information changes during the school year, I will bring the change to the immediate attention of the Superintendent of SVRSU #12. I understand that if I enroll a student in the SVRSU #12 illegally, enrollment will be terminated immediately, and a report may be made to the authorities. Theft of services is a crime. I further understand that I will be responsible for all expenses incurred by the Town of Alna and SVRSU #12, should I illegally obtain educational services.
